Analysis of Retail Managed Funds December 2021 - Marketer View

\$32.4bn Increase in Retail Managed Funds reported during December 2021 Quarter

Retail Managed Funds rose 3.0% in the December quarter to \$1,114.0bn so that over the whole of 2021 they were up 15.2%. Continued strong investment earnings were responsible for over 70% of the growth. Meanwhile global stock markets still remain vulnerable to a long overdue sustained bear market correction as governments now start to grapple with reining in newly reignited inflation problems caused by many years of "loose/cheap" monetary policy. All of the leading companies reported increases in their Retail Funds in 2021. In particular Insignia Financial (161.8%), which is the new name of IOOF, and HUB24 (127.6%) saw their Retail Funds more than double in size due to their respective acquisitions of MLC and Xplore. Meanwhile netwealth (45.6%), BT (45.2%), Macquarie (28.4%) and Praemium (28.3%) also all finished substantially higher.

Gross Inflows for 2021 totalled \$197.9bn, up 9.0% on those reported in 2020 despite declining 6.6% in the December quarter.
