Analysis of Retail Managed Funds as at March 2021 – Administrator View

\$27.7bn Growth in Retail Managed Funds Reported during March 2021 Quarter

Overall Retail Managed Funds bounced back strongly from the COVID-19 selloff suffered in early 2020, up 17.4% over the past year to total \$998.6bn. Over the March quarter they were up 2.9% with markets subsequently further strengthening so that at date of publication some markets are in record territory despite many experts still predicting an overdue sustained correction. Over the past year most Retail companies reported double digit plus increases in their funds under management led in percentage terms by Praemium (223.7%), HUB24 (135.7%), netwealth (49.4%), Macquarie (28.2%), Mercer (17.9%) and BT (17.8%). The jumps recorded by Praemium and HUB24 were thanks to their acquisitions of Powerwrap and Xplore.

Gross Inflows decreased by 6.3% to \$42.0bn during the March 2021 quarter while year on year they were also 5.7% lower. Annual Inflows into the main Superannuation, Retirement Income and Unit Trusts & Investment Funds markets were all down by 6.1%, 13.5% and 5.0%. Meanwhile the much smaller Investment Bond and Cash Trust markets were mixed with Inflows down 2.4% and up 19.2%.
