

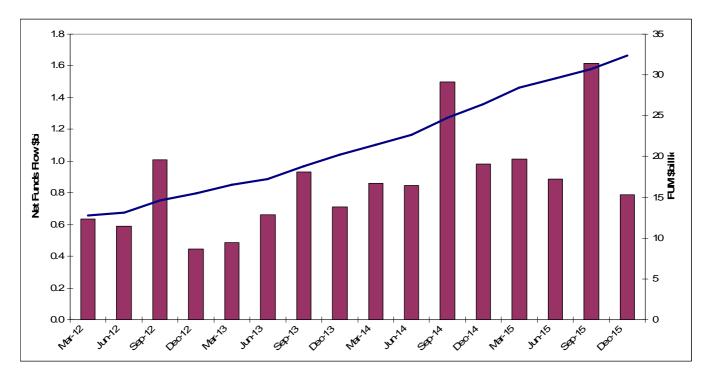
KiwiSaver Funds Under Management at December 2015
